- The need to provide students with equal opportunities in distance educational assessments; in order to measure their performance in a transparent and credible manner, in addition to raising families' awareness of the requirements of distance assessment.
- To prepare the proctors to deal with the main problems that students may encounter, assist them in overcoming technical difficulties and provide a comprehensive manual for testing situations, the platform used, and how to use it. This is to ensure that students receive and understand this information. There is a also a need to teach them the meaning of practice tests and their requirements. Such that the testing systems and regulations are updated to include the duties and penalties related to distance tests, as well as diversifying the assessment activities; to ensure maximum benefit from the technologies used and credibility and security of tests.
- The need for the virtual college admission test (SAT) environment to be similar to that of conventional SAT, in terms of close monitoring and provision of support when necessary.

- To work on developing virtual laboratories in education and training institutions and implementing the best practices in e-learning, in addition to working on establishing an electronic education centre to support e-learning.
- To highlight on adapting the virtual training approach to meet the learners' needs and invest in the technological progress. This would help in including the virtual mode of delivery as part of the offering courses/ programmes and support the institutions in introducing new and innovative mode of delivery in distance learning.
- To focus on the importance of having a clear strategic vision for education and training institutions, as well as having
  mechanisms and legislations that contribute on learners' skills development. On the other hand, offering flexibly designed
  courses would also support learners and enhance mode of delivery in appropriate manner, such as distance, blended or
  in-class learning.


