

Introduction

The Directorate of Government Schools Reviews (DGS), which is a part of the Education & Training Quality Authority (BQA), conducted this review over three days by a team of nine reviewers. During the review, reviewers observed lessons and other activities, scrutinised students' written works and analysed the school's performance data and other documents. They spoke to the staff, students and parents. This report summarises their findings and recommendations.

Judgement justifications

- The schoolwork aspects have improved from satisfactory to good, while the aspect of students' personal development remain as good.
- The school's new comprehensive strategic plan, with clear performance indicators, has been effective in developing the overall performance according to the development priorities, based on the results of the accurate and comprehensive selfevaluation.
- Most teachers employ effective teaching and learning strategies and resources, the best use of which is in the good and outstanding lessons that
- account for more than half of the lessons, being focused in the scientific subjects' lessons in the three levels and most Arabic and English lessons, especially in Grade 10 and scientific track. The least use of these strategies and resources are in the satisfactory which are affected management of learning time and by the variation in supporting lowachieving students and considering differentiation. It is worth mentioning that none of the lessons were judged as inadequate.
- Students achieved high pass and proficiency rates in most subjects in the

- 2016-2017 ministerial examinations, these being in line with their actual levels in most lessons. However, they were inconsistent with their levels in most commercial subjects' lessons.
- Most students contribute to school life with high self-confidence and ability to take responsibility when assuming leadership roles in lessons and the various school committees and activities. They behave well, commit to citizenship values and feel emotionally secure.
- The school meets the academic and personal needs of all students in a good manner. A wide range of extracurricular activities is provided which suit the preferences and interest of students, especially the outstanding and talented, and significant support is provided to disabled students.
- Students and parents are satisfied with the school's provision.

Main positive features

- The effectiveness of strategic planning processes, including the accurate and comprehensive self-evaluation of all schoolwork aspects.
- The variety of teaching and learning strategies and effective use of educational resources, especially in scientific subjects' lessons, Grade 10 lessons and the majority of Arabic and English lessons.
- Most students' contribute to school life with great enthusiasm, high self-confidence and the ability to take responsibility.
- Most students' adherence to good behaviour and citizenship values, and their feeling of emotional security.
- The support and assistance programmes provided to most students of different academic capabilities.

Recommendations

- Utilise teaching and learning strategies more effectively, focusing on:
 - developing the basic skills in commercial subjects and mathematics in general
 - managing learning time more productively
 - supporting low-achieving students
 - considering differentiation and challenging students' abilities through activities and written work.
- Address the shortfall in human resources represented by senior teachers for the English, mathematics, science and commercial subjects departments.

Judgement justifications

- The improvement of schoolwork aspects from satisfactory to good levels, while students' personal development aspect remain at the good level.
- The accurate, comprehensive and multi-mechanism self-evaluation, and benefiting from its results in developing, implementing and monitoring the strategic plan.
- The consistency between the school's assessments of all aspects, as provided in the Self-Evaluation Form (SEF), and

- the judgements of the review team, reflecting the school leadership's positive awareness of all work aspects.
- The school's success in coping with the challenges it faces, such as the shortfall in the middle leadership of most core subjects departments (English, mathematics, science and commercial subjects), and the old school building with its overcrowded classes in some grades.
