

## Directorate of Government Schools Reviews Short Monitoring Visit Report

Sitra Primary Boys School Sitra – Capital Governorate Kingdom of Bahrain

#### Introduction

The monitoring visit of the school took place over one day, by a monitoring team from the Directorate of Government Schools Reviews (DGS) of the Education and Training Quality Authority (BQA) to verify the improvements that it enacted according to the overall outcomes of the first monitoring visit. During the monitoring visit, improvement in students' performance is evaluated during the class observation, the learning walk, scrutiny of their written works and monitoring of general progress.

#### Summary of the second monitoring results

#### The overall outcomes of the visit

- Raise students' academic achievement and develop their basic skills in subjects, especially in English in both cycles and in Arabic in Cycle 2.
- Carry out a more accurate self-evaluation and set systematic mechanisms to monitor the strategic plan.
- Monitor the impact of professional development programmes on the improvement of teaching and learning, focusing on:
  - efficient productive classroom management
  - students' roles activation, and promotion of their self-confidence and assumption of responsibility.
  - utilization of effective assessment techniques, and ensuring accurate marking of written work in general.
  - Students' support and consideration of their academic levels in lessons and written work.
- Continue to address the shortage in school facilities; represented by a gymnasium and toilets and in human resources; represented by senior teachers for class teaching, mathematics and social worker.

#### Additional remarks

• In addition to the abovementioned, the school should re-conduct the self-evaluation; so that it reflects the school's situation, and use its results to set the strategic plan, while ensuring the monitoring of such, according to clear and accurate performance indicators; in order to improve the school's overall performance.

Judgement	Judgement Description
Sufficient Improvement	The school is making significant progress in addressing the recommendation. It has taken measures, which have achieved great improvement linked to the recommendation, which clearly resulted in improved performance, and positively impacted the outcomes.
