

# Directorate of Government Schools Reviews Short Monitoring Visit Report

# Al-Imam Ali Primary Intermediate Boys School Al Ma'ameer – Capital Governorate Kingdom of Bahrain

Date of first monitoring visit: 28 March 2018

## Introduction

The monitoring visit of the school took place over one day, by a monitoring team from the Directorate of Government Schools Reviews (DGS) of the Education and Training Quality Authority (BQA) to verify the improvements that it enacted according to the recommendations of the last review visit. During the monitoring visit, improvement in students' performance is evaluated during the class observation, the learning walk, scrutiny of their written works and monitoring of general progress.

The school was judged 'Inadequate' in the April 2017 review visit

#### The overall outcomes of the visit

In order to have sufficient measures and improvements, the school is required to:

- Seek intervention by the relevant parties at the Ministry of Education to support the management efforts in order to ensure the improvement of the school's overall performance through:
  - conducting accurate and comprehensive self-evaluation and using its results in developing the strategic plan while focussing on improvement priorities and defining clear performance indicators and accurate monitoring mechanisms
  - address the shortfall in human resources, represented by senior teachers for the mathematics and class teaching.
- Raise students' academic achievement, particularly in Cycle 2 and Cycle 3 mathematics, and develop their basic skills in core subjects, particularly in English.
- Monitor the impact of teachers' professional development programmes on the development of teaching and learning strategies, to include:
  - organised and productive class management
  - implement assessment for learning and using the results to meet the educational needs of all groups of students
  - developing students' self-confidence, motivating and encouraging them to increase their interest to learn.
- Support all groups of students, both in and out of lessons and in written work, and conduct effective school activities to enhance their learning experiences and varied interests.

#### Additional remarks

• The school needs to address the shortfall of a senior teacher for the English department.
