

## Directorate of Government Schools Reviews Short Monitoring Visit Report

# Sh. Mohd Bin Khalifa Al-Khalifa Primary Intermediate Boys School Al-Budaiya – Northern Governorate Kingdom of Bahrain

### Introduction

The monitoring visit of the school took place over one day, by a monitoring team from the Directorate of Government Schools Reviews (DGS) of the Education and Training Quality Authority (BQA) to verify the improvements that it enacted according to the overall outcomes of the first monitoring visit. During the monitoring visit, improvement in students' performance is evaluated during the class observation, the learning walk, scrutiny of their written works and monitoring of general progress.

### The Previous Judgement

The school was judged as 'In progress' in the first monitoring visit which was conducted in December 2016.

In order to have sufficient measures and improvements, the school is required to:

- Seek intervention by the relevant parties at MoE to support the efforts of the different levels of school leadership, so as to contribute to the development and improvement of the school's overall performance as per the requirements of each educational cycle.
- Raise students' academic achievement in core subjects, especially in English and mathematics in the second and third cycles.
- Develop teaching and learning strategies, so as to ensure:
  - the variation in the methods of assessment for learning, and utilising their results to support and meet the educational needs of all students
  - organized and productive class and time management
  - students' participation in educational activities in a way that enhance their selfconfidence.

### Additional remarks

Redevelop a strategic plan based on an accurate self-evaluation that is inline with development priorities.
